Aurivo has its headquarters in Sligo based in the Northwest of Ireland with operations across a multitude of sites including two dairy processing plants, one animal feed mill, 34 Homeland stores, four livestock marts and offices based in London.

Opportunity

An exciting opportunity has arisen in Aurivo Dairy at our Consumer Foods site in Achonry, Co Sligo for the role of Warehouse and Distribution Site Manager. Reporting to the Head of Operations Consumer Foods, the successful candidate will have responsibility to ensure the management of operations, supply chain, quality, health and safety related processes are effectively managed to support the current and future needs of the business.

At this site we distribute over 6,000 Tonnes of retail butter and 60 million litres of liquid milk per annum. The site operates seven days per week, in a multi-shift, temperature-controlled environment. The principle of a just in time supply chain applies and the site is moving to a more digitised platform in 2023.
