Full details of the role you will initially be required to take on are detailed here, but there will be lots of room for advancement into the future.

### **Key Responsibilities:**

- Operation of the Wastewater Treatment Plant (WWTP) process mainly outdoor work
- Gain familiarity with all WWTP equipment and processes
- Manage dry sludge production including shunting sludge trailers as required
- Maintaining chemical addition to processes where required i.e. DAF, dewatering and final settlement
- Cleaning and washing of equipment, managing chemical stocks, bunding chemicals and emptying bunds and tanks, and general tidying of the WWTP area
- Perform daily checks of all equipment to ensure correct operation and no blockages
- Take daily water samples and perform daily / weekly monitoring tests required for optimum operation of the plant and as required by the licence
- Manage disposal of waste chemicals and empty IBC's
- Carry out minor repairs, hose changes and clearing of blockages
- Comply with all Health & Safety requirements including working alone procedures.

### **Requirements:**

The ideal candidate will have:

- An environmental / WWTP qualification or be willing to undertake such training
- Hands on practical ability in setting up pumps, connecting hoses and couplings etc.
- HGV driving experience
- Forklift driving experience
- Good computer and report writing skills
- Excellent communication skills
- Must be capable of working alone and on their own initiative.
